County councillor's monthly report for April 2020

For the Histon and Impington (H&I) county council division of Cambridgeshire which also includes King's Meadow and Orchard Park.

Following the sudden close down of all council activity there's been a return with many committees meeting virtually this month. There's been some argument about how they should meet but despite the concerns about it's security Zoom is the application of choice with Microsoft Teams being used if meetings have to go into a secret session. Because such applications are being used all meetings are now recorded and broadcast on YouTube.

As a part of its role in the Strategic Coordination Group the Council has taken on the responsibility to make and stay in contact with people who are identified as shielded and/or in high risk of severe illness. It claims to be in contact with such people weekly and is making a push to maximise its coverage of these people during May.

It seems like we're getting too much Covid-19 information about what's happening globally and nationally; it would be useful to know what's happening locally. The Organisation for National Statistics reports deaths by district council ward and it seems that there's been just 1 for Histon & Impington (including Orchard Park). Click here for that information. As of last Wednesday there are reported to be 1152 cases in Cambridgeshire which is about 17.5 cases/10000 people. That puts the county well below the national average.

Full Council meeting

There was no meeting of Full Council but there will be a virtual one in May.

Committee meetings and other council matters

Most meetings seemed to be just a matter of starting up again with nothing substantive on the agenda and the only items of interest being the Covid-19 updates.

Adults, Children & Young People, Highways & Infrastructure, Health: these committees did not meet

<u>Communities & Partnerships</u>: this committee met. There were no key decisions but the committee agreed to support two applications for funding from the Cultivate stream of the Innovate & Cultivate Fund.

<u>Economy & Environment:</u> there was a key decision relating to the award of the Design & Construction contract for the King's Dyke project in Whittlesey.

<u>Commercial & Investment</u>: there were no key decisions but a secret session about a new This Land business plan.

<u>General Purposes</u>: this committee met. In its one key decision relating to various financial transactions it approved top-up and contingency funding for the King's Dyke project

The <u>Planning</u> committee did not meet. It has not met since Oct 19 and its next meeting has been further (again) pushed back to Jun 20.

There was a meeting of the <u>Constitution & Ethics Committee</u> which I do not generally report. Sadly the Committee agreed by a majority to wind up the Cambridge Joint Area Committee and to withdraw from the Cambridge Fringes Joint Development Control Committee. Both decisions were taken in the absence of any meaningful evidence and in defiance of much public and other council opposition. My take on the meeting is at https://wp.me/p7tuu7-1VW.

The <u>Cambridgeshire Police & Crime Panel</u> did not meet. Its end March meeting was cancelled and it has not yet set a next date to meet.

The Cambridgeshire & Peterborough Fire Authority did not meet.
