Covid-19

Vaccination

New instructions from NHS Cambridge and Peterborough CCG are that any patients who are aged 55 and above, and live in Cambridgeshire and Peterborough, are now being called for their first COVID-19 vaccination. They can book their appointments directly using the website http://www.nhs.uk/covid-vaccination or by calling 119, or they can get in touch with their GP practice to book their vaccination appointment.

Fens Biosphere Reserve

At the Council meeting of 23rd February the Council passed a motion proposed by Cllr. Pippa Heylings and seconded by Cllr Martin Cahn which asked the Council to write to formally support the proposal for a Fens Biosphere Reserve, and instructed the leader to write to adjoining local authorities to encourage them to do the same. The Fens were awarded candidate status for a UNESCO biosphere reserve in November 2019. Biosphere reserves are part of UNESCO's Man and Biosphere programme and the aim of the designation is to encourage management of the area in a manner which connects people, the economy and nature in a manner in which all can thrive.

The proposed designation area includes parts of South Cambridgeshire. These areas would fall in the transition and buffer zones and would include Histon and Impington. Since this meeting both Cambridge City Council and East Cambridge District Council have followed suit and a positive reaction has been received from other councils.

Pension Funds

In the meeting of Council on 23rd February a motion was also passed which asks the Council to write to the investment sub-committee of the Pension Fund Committee of the Local Pension Board asking how they intend to take the financial risk of climate change into account in their investment policies. The objective is to encourage investment policies that neither add to climate change nor expose the pension fund investments to excessive risk thus securing the future pensions of the pension fund members. Cllr Martin Cahn should perhaps express an interest here – he receives a local authority pension, although not from the Cambridgeshire scheme.

HGV Motion

Another decision from Full Council was the passing of a motion about the impact of increased goods vehicle movements on our communities, especially in light of changing shopping patterns due to lockdown restrictions. Council requested the Leader to write to the Secretary of State for Transport to request that the government take fully into account the effects of HGV traffic on rural communities when considering changes to current regulations on weight and include supporting evidence of the increases. Council also requested the Leader write to the County Council to ask that it facilitates the use of measures to make our village roads safer and improve the daily lives of our residents.

Bourn Airfield Development

The outline planning application for the Bourn Airfield new village was passed at Planning Committee on 19th February with permission granted for an initial phase of 500 houses. No further development will be permitted until a transport assessment is completed as development proceeds and it is demonstrated that future phases can be suitably accommodated on the network. A new fast transport solution is panned between Cambourne and Cambridge serving the development. It is planned that this village will eventually cater for 3500 houses, and so it will form an essential support to housing supply in the district. Thus it is important in maintaining our 5 year housing land supply and thus ensuring that unsuitable housing sites are not approved elsewhere in the district on appeal.

Police Station

Planning Committee approved the plans for the new Police Station near Milton, subject to conditions for EV charging and CCTV coverage of the A10 footbridge. An informative was added to request maximum on-site power generation.

Zero Carbon Communities Grants

It was great to see the first batch of trees planted by Histon & Impington Trees Action Group as they work to restore a green gateway to the villages. Thanks to the volunteers for their hard

work and campaigning, and to all who have supported the project with donations of money, trees, and labour. SCDC was proud to support this work with a £6,500 grant from the Zero Carbon Communities scheme. Applications for the next round of ZCC funding opens in May and applications will be accepted until 30th July. Applications are invited for projects under the three themes:

- Community buildings
- Tree Planting/Nature
- Other projects which reduce carbon emissions

OxCam Arc

There have been notices in the press recently concerning the government's intentions to provide more detail on the development of the OxCam Arc – a growth corridor between Oxford and Cambridge. This is an area of the country marked out for significant development in terms of jobs, housing, infrastructure. There is also now more attention to the impact of climate change on the way development takes place. The green agenda, with an emphasis on low carbon initiatives, on biodiversity, on landscape and water management is very much being led by South Cambs – particularly through the work of the Leader, Bridget Smith and that of Chief Executive, Liz Watts.

It is important for our area, our villages, that we keep abreast of these developments and have an input into the developments; and elected councillors will be doing just that. We have **attached to the end of this report** information from a presentation made recently giving more details of the development of the spatial framework; and we will continue to report as and when further information comes forward.

APPENDIX : OxCam ARC Spatial Framework : points taken from a recent government document


PURPOSE:

- 1. support long-run sustainable economic growth across the area
- 2. help to make the area a brilliant place to live, work and travel in for existing residents and future communities alike
- 3. Support lasting improvements to the environment, green infrastructure and biodiversity

Approach to the Framework – 10 Principles

The Areas Economy – Spatial Framework will...

- provide an assessment of existing employment land, planned growth and anticipated future need
- set policies to support local planning authorities in allocating these as Strategic Business Zones or Strategic Industrial Locations, as appropriate
- set policies to support different land uses for different sectors and sizes of business

The Environment

Setting policy to...

- support retention of, and investment in, key existing and potential new habitats, and improve access to nature and accessible green space
- set high standards for new development, including on carbon emissions, water management, green space, integrated and functional green infrastructure, e.g. for active travel and biodiversity net gain
- support an integrated water management approach, taking into account sustainable water abstraction and drought resilience, water quality, reducing risk and resilience to flooding and how and where new infrastructure should be developed
- support clean air outcomes, with clear links to housing and transport policies embed the enhancement of natural capital across the Arc Includes objective to identify Environment "Opportunity Areas"

Transport and Infrastructure in the Arc

targeted climate resilience and air quality policies based on air quality modelling

wider strategic policies to facilitate utilities investment in line with key development opportunities, including digital infrastructure

Housing and Planning in the Arc

- "...We will plan for the right level of growth in the Arc... to do this the spatial framework will identify:"
- Opportunity Areas, to support local planning authorities to plan for this growth
- the **infrastructure** needed to support sustainable growth in those locations, and the key locations for strategic infrastructure to support sustainable growth
- **locations for environmental enhancement** to achieve greater environmental benefits that can allow development to take place elsewhere

Spatial Framework - polices to enable...

- new settlements to come forward at the scale and speed needed
- new development to **support** habitat recovery, delivery of Local Nature Recovery Strategies, and provision of good-quality green space within schemes
- brownfield redevelopment and densification, and expansion of existing settlements, in sustainable locations or **locations that can be made more sustainable by enhanced access** to sustainable transport modes
- housing needs to be met in full, including delivery of much-needed affordable housing
